

## **ACTION PISTOL SHOOT – OUTDOOR “FAREWELL TO SUMMER” STEEL SHOOT**

**Sponsor:** Pine River Sports Association, Ltd. (PRSA)  
Richland Center, WI 53583

**Location:** Richland County Outdoor Range  
24820 Cooper Hill Rd. (Past Fairgrounds – AA to SR, turn right off County SR)  
Richland Center, WI 53924

**Date & Time:** September 29<sup>th</sup>, 2018  
Registration - 9:00-10:00am - Firing begins promptly at 10:00am.

**Entry Fee:** \$10.00 – Re-entry allowed for additional fee.

**Open To:** Anyone - 18 years of age or older.

**Rules:** Published and posted rules.

**Classification:** 2 Divisions, Rim Fire and Center Fire - 2 Classes, Production and Open

**Course of Fire:** Custom Action Pistol Course, Steel Plates. Competitors will fire in groups.  
3 Stages, 3 Runs per stage, total best score of 2 runs for awards.

**Distance:** Varies – 21 to 35 Feet, target heights may vary.

**Target:** White Steel Plates w/ Red Stop plate. 3 Shapes.

**No. Rounds:** 90 - 3) magazines of 10 x 3 Stages x 3 Runs/Stage. Shooter may not accumulate unfired rounds across stages.

**Scoring:** Electronically Timed - w/Penalties, 5 seconds per no hit; 30 seconds for a stop plate not hit or hit out of designated sequence.

**Equipment:** Handgun with 3) Magazines, loaded with a maximum of 10 rounds each.  
Handguns with arm braces or slings not allowed, includes Open class.  
Holsters are optional, eye & ear protection is shooters responsibility.

**Awards:** 33% of entry fee. Places paid will depends on # of shooters, must be 5 shooters minimum per class, if less than 5, classes will be combined.

**Stage 1** NEAR to FAR: 4) Rectangular Plates, distance 21 - 35 feet, 1) STOP plate.

**Stage 2** SPEED: 4) Circular Plates at 25', 1) STOP plate.

**Stage 3** FAR to NEAR: 4) Mini-Silhouette Plates, distance 35 – 21 feet, 1) STOP plate.

The STOP plate must be hit last, its location in each Stage will vary.

Groups of shooters will fire in sequence. Each shooter will fire 3 Runs in sequence at each stage.

Disagreements or challenges will be decided by the RSO & Match Director.
